

## Contract to participate in the High-Level Council of the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY

English version 1.0-2019.

This agreement is based on the Brazilian Federal Law No. 9,608 of February 18, 1998, and in the TERM OF ACCESSION TO THE BODY OF SPECIAL CIVIL DEFENSE VOLUNTEERS FROM THE STATE OF *RIO GRANDE DO SUL*.

The purpose of this agreement is to ensure that the members of the High-Level Council of the *SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY* know that they are volunteers in this service and understand their obligations and rights as board members.

## Here are the terms:

- 1- This contract is valid preferentially receipt of a hard copy signed by the candidate for the position of a board member:
- § 1° The contract is sent by the interested party.
- § 2° The interested party must request the address to send the correspondence To the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY; an e-mail address will be provided.
- 2. The members of the High-Level Council of the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY may not, under no circumstances:
- A) Disclose it's evaluations to third parties;
- B) Transfer the articles to other magazines or any other means of disclosure other than the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY;
- C) Committing plagiarism crimes. Such a crime is a disgrace to the Council, the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY and the Scientific Community. The punishment for this foul will be severe.
- D) You can't make comments about the manuscripts sent to their evaluation outside the High-Level Council of the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY;
- E) Members of the High-Level Council of the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY Inactive or not cooperating when requested with the operation of the journal will not Their names published in the credits;
- F) "Inactive" means those members who no longer respond to so-called or Requests from the rest of the board;
- G) Omitted cases will be judged separately.
- H) You usually must submit three original manuscripts of yourself, or related to yourself, to complete your acceptance process.

## Of the rights of the members of the council:

3- The members of the High-Level Council of the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY will be entitled to:

- A) To have its name published in the Editions of the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY in which, participate in, that is, when they carry out an evaluation or relevant work;
- B) If available, members may request the use of E-mail redirection similar to the following example: your name@sbjchem.com;
- C) Bonuses and special thanks may be given to the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY High-Level Council that stand out in their provision of services to the community;
- D) The evaluation of articles will be done in pairs;
- E) The members of the High-Level Council of the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY may veto Articles that are not consistent with reality.
- E.1) In case there is disagreement between the veto and the approval, the vote of *Minerva* or the choice of the vote of *Minerva* is reserved to the editors of the magazine.

The members of the high-Level Council of the SOUTHERN BRAZILIAN JOURNAL OF CHEMISTRY may request, through the Editor, additional information to the authors of the articles, in order to formulate better an opinion or solve doubts:

- F) Members agree to receive the original articles for evaluation without Information about the authors. Such a condition is proposed to ensure the impartiality of the Evaluator;
